#### 7. Explanations

#### Explanations of the procedure

The purpose of the background check (ZÜP) is to protect against attacks on the security of civil aviation, in particular against aircraft hijackings, acts of sabotage and terrorist attacks.

The aviation security authority may only use the data collected for the purpose of checking reliability.

If the Aviation Security Authority is required to assess you as unreliable within the meaning of Section 7 LuftSiG on the basis of the results of the check, you will be given the opportunity to comment on the available findings beforehand. For the duration of the validity of the ZÜP, you are subject to the follow-up report. Each authority involved in the application procedure will inform the competent authority of any relevant findings concerning your person for the duration of the ZÜP. The findings (e.g. criminal proceedings) may lead to the revocation of the ZÜP.

#### Declaration of the applicant

I agree to undergo a background check (ZÜP) on the basis of § 7 LuftSiG.

The Aviation Security Authority may, by providing my data:

- make inquiries with the police enforcement and constitutional protection authorities of the federal states, the Federal Police and the Customs Criminal Investigation Office and, to the extent necessary in individual cases, the Federal Criminal Police Office, the Federal Office for the Protection of the Constitution, the Federal Intelligence Service and the Military Counter-Intelligence Service and the Federal Commissioner for the Records of the State Security Service of the Former German Democratic Republic (DDR) about available information relevant to the assessment of reliability
- obtain unrestricted information from the Federal Central Register, information from the Education Register and information from the Central Public Prosecutor's Proceedings Register,
- in the case of foreign persons concerned, request information from the Central Register of Foreigners and, insofar as necessary in the individual case, direct enquiries to the competent foreigners authorities regarding indications that the person concerned may have an adverse effect on public security,
- to the extent necessary in individual cases, make enquiries of aerodrome operators and air carriers as well as of the employers of the last five years and the current employer of the person concerned as to information available there which is significant for the assessment of reliability.

If the information provided by the aforementioned authorities gives rise to doubts as to the reliability of the person concerned, the Aviation Security Authority may obtain information from law enforcement authorities.

I am obliged to cooperate. Insofar as this is required in individual cases, this duty to cooperate may also include the obligation to provide a medical opinion if facts give rise to the assumption of alcohol or medication dependence, or to carry out a test for narcotics in accordance with the Narcotics Act. This obligation also applies if the review has already been completed but there was or is evidence of abuse of alcohol, medication or narcotics.

I acknowledge that

- the result of the check will be forwarded to the federal and state police and constitutional protection authorities involved and to the Customs Criminal Investigation Office.
- my above-mentioned personal data and information on the result of the background check will be stored in the IT system of the responsible Aviation Security Authority and the airport operator.

My personal data processed within the framework of the background check will be stored

- 1. by the Aviation Security Authority
  - a. in the case of a positive decision, for up to three years after the expiry of the validity of the background check
  - b. in the case of refusal or revocation of good repute up to 2 years after refusal or revocation
- from the above-mentioned authorities and bodies involved for up to 5 years and 3 months from the date of the request by the Aviation Security Authority.

If there is reason to believe that my interests worthy of protection would be impaired by the deletion, the processing of the data must be restricted. Restricted data may only be processed without my consent if this is indispensable to avert a significant danger.
